Arranged BV, with registered office at Meremweg 37C, 3740 Bilzen, appearing in the register of legal entities of Antwerp, Tongeren division under number 0836.709.429 and known to the VAT authorities under number BE 0836.709.429 (hereinafter referred to as "**Arranged**") uses cookies to improve the surfing experience on <https://www.green-ammonia.be> (hereinafter referred to as the "**Website**").

These cookies enable certain functions on our website or measure how visitors use our website.

By means of this cookie policy ("Cookie Policy"), we wish to inform you, as a visitor to our Website, about the cookies and other tracking methods we use (and how we do this).

### What are cookies ?

A cookie is a small text file that is placed by the server of a website or platform in the browser of your computer or on your mobile device when you consult the website. The cookie contains a unique code that allows your browser to be recognized during visits to the website (a so-called 'session' cookie) or during subsequent, repeated visits (a so-called 'permanent' cookie). Cookies can be placed by the server of the website you visit or by partners with whom the website cooperates (such as e.g. Google Analytics). The server of a website or platform can only read the cookies it has placed itself and has no access to other information stored on your computer or mobile device. Cookies are stored on your computer or mobile device in the folder of your browser.

Cookies generally make interaction between the visitor and the Website easier and faster and help the visitor to navigate between the various parts of the Website. Cookies can also be used to make the content of the Website more relevant to the visitor and adapt it to his personal taste and needs.

### This Website uses different types of cookies and tracking methods:

#### I. Technically essential cookies:

These cookies are necessary for purely technical reasons for the use of the Website. In view of the technical necessity, there is only an information obligation and they are placed as soon as one enters the Website.
